ORDINANCE NO. 176237

* Authorize the Chief Administrative Officer or his designee, with City Attorney review and approval, to execute non-disclosure agreements, contracts and applications for Competitive Local Exchange Carrier compliance requirements. (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

- 1. The IRNE network project was approved by Council in the FY 2001-02 budget.
- 2. The IRNE network will require a carrier grade voice switch, voice mail system, and other network and customer equipment to provide voice and data services.
- 3. The City of Portland dba IRNE has received a certificate of authority from the Oregon Public Utilities Commission (OPUC) to operate the IRNE as a Competitive Local Exchange Carrier (CLEC).
- 4. Activities of CLEC's are regulated by the OPUC and the Federal Communications Commission (FCC).
- 5. The IRNE's compliance with regulatory requirements necessitates that it participate in SS7 (switch administration services) databases, carrier access billing arrangements, number portability services and other specific business relationships required by the OPUC, the FCC and the Interconnection Agreement (ICA).
- 6. The City has retained an expert consultant, CHR Solutions, to advise ComNet on compliance. CHR Solutions has advised the Bureau of Communications and Networking that multiple agreements and applications will be required for signature to meet compliance and project deadlines.
- These compliance-related agreements are a necessary operations activity of the IRNE to provide switched services under the rules of the FCC and OPUC.
- 8. Funds for these contracts, agreements and applications are available in the Bureau of Communications and Networking's and the IRNE project capital and operating budgets.

NOW, THEREFORE, the Council directs:

- a. The Chief Administrative Officer (or his designee), with City Attorney review and approval, is authorized to execute the following agreements, contracts and applications for services directly related to compliance with the ICA, OPUC requirements and FCC requirements, including:
- 1) Operator Services/Directory Assistance agreements.
- 2) IntraLATA Toll Termination Agreements
- 3) Pole Attachment and Innerduct Occupancy Agreements.
- 4) Yellow Page Agreement
- 5) Agreement with SCC Communications Corp. for 911 database services
- 6) Neustar number portability administration agreements and nondisclosure agreements and SOA services agreements.
- 7) Illiuminent SS7 contract.
- 8) Qwest SS7 services agreement.
- 9) Revenue Accounting Office Service Agreement.
- b. The Chief Administrative Officer (or his designee) is authorized to execute amendments, with the review and approval of the City Attorney, which are in the best interest of the City of Portland IRNE project.
- Section 2. The Council declares that an emergency exists in order that there be no delay in implementation of IRNE; therefore, this Ordinance shall be in force and effect from and after its passage by the Council.
