ORDINANCE No. 188847

*Authorize a contract with the lowest responsible bidder for the NE Halsey-Weidler Streetscape Project: 102nd – 112th (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

- 1. Prosper Portland worked with the public and community partners to create the Halsey/Weidler Investment Strategy ("Investment Strategy") in 2013-14.
- 2. The Investment Strategy identified opportunities to improve the Halsey/Weidler Business District including a Streetscape Vision for infrastructure improvements that would improve district safety and identity.
- 3 In July 2015, Prosper Portland and the City of Portland Bureau of Transportation (PBOT) entered into an Intergovernmental Agreement (IGA) for the design of the NE Halsey-Weidler Streetscape Project: 102nd – 112th ("Project").
- 4. The Project scope includes pedestrian safety and crossing improvements, protected bike lanes, NE 103rd Avenue Improvements and East Entry Triangle improvements.
- 5. The project is identified in the City's Capital Improvement Program (CIP)
- 6. The Bureau of Transportation has funds budgeted in FY 2018-19 for construction, inspection and management of the project.
- 7. The Bureau's level of confidence in the cost estimate for this project is moderate; the project is defined and plans and specifications are finalized.

NOW, THEREFORE, the Council directs:

- a. Upon the Council's acceptance of the Chief Procurement Officer's report recommending the lowest responsible bidder, the Chief Procurement Office is authorized to negotiate and execute a contract, provided the contract has been approved as to form by the City Attorney's office.
- b. The Auditor to draw and deliver warrants chargeable to T00456 when demand is presented and approved by the proper authority.

Section 2. The Council declares that an emergency exists because the project must be bid in April 2018 in order to be under construction summer 2018; therefore, this Ordinance shall be in full force and effect from and after its passage by the Council.


