# Purpose of proposed legislation and background information:

This amendment to Title 30 will amend the Mandatory Relocation Assistance Policy to change the policy from temporary to permanent and clarify the code language for ease of use.

## **Financial and Budget Impacts:**

The Housing Bureau is tasked with providing the public with information and assistance pertaining to relocation assistance. This ordinance's amendments to the relocation assistance policy would additionally require the Bureau to intake data and forms relating to requesting exemptions from relocation assistance and the transaction of issuing relocation payments. The collection of this data would be the beginning of a rental registration database.

To meet the requests of Council and the community stakeholders on the relocation assistance technical advisory group in providing these services, the Bureau is asking for ongoing general funds to cover two new staff as well as funds to procure the software needed for a rental registration system in an add package request for FY 18-19. The Bureau will assign current staff from existing work to cover the additional work in the interim.

- \$194,700 additional general fund ongoing for 2 Assistant Housing Program Specialist for technical assistance calls/email and mandatory rental unit registration system development and management
- \$200,000 to develop requirements for a rental registration system

## Community impacts and community involvement:

The lengthened implementation of this policy will mean continued effects on renters and landlords. The former group will continue to have an amount of financial support if they are involuntarily displaced from their homes due to eviction or rent increases of 10% or more. The latter group will need to continue to weigh their business decisions (those of evictions and rent increase) in light of the financial prices they may incur as a result.
