## Purpose of proposed legislation and background information:

In December 2016, Council adopted the Open and Accountable Elections ordinance which created a matching funds program for qualifying candidates. After consideration of multiple alternatives, the program was placed in the Office of Neighborhood Involvement (ONI) with the approval of the Commissioner-in-Charge and Director at that time.

The Commissioner-in-Charge and Director of ONI changed in 2017 and requested that the program be housed elsewhere in the City. At Council's direction, the City Budget Office conducted a study which considered options for location of the Open and Accountable Election Program. After consideration of their report and a thorough review of options, it was determined that the most feasible option was to house the program would be in a Commissioner's Office.

Understanding that there would be a conflict of interest in having a Commissioner responsible for supervising a program while using or having an opponent use the program, a Commissioner would not be eligible to provide oversight to the program during the final two years of their term.

### Financial and budgetary impacts:

In the 2016-17 Adopted Budget, \$1.2 million of ongoing funds were allocated to the program. This action will have no impact on that existing allocation of funds.

# Community impacts and community involvement:

Extensive public involvement was conducted during development of the program in 2016. For these amendments, the changes were presented to a group of community advocates that were instrumental in the development of the program.
