

ORDINANCE No. 188862

*Amend contract with Oregon Department of Transportation for the NE Columbia Blvd at OR 99E/MLK Jr. Blvd project (Ordinance; amend Contract No. 30005854)

The City of Portland ordains:

Section 1. The Council finds:

1. On September 7, 2011, Council approved Ordinance No. 184849 that authorized a grant funding that covered the total anticipated cost for engineering and right-of-way of the project, estimated at approximately \$1,500,286.00.
2. The NE Columbia Boulevard at OR 99E/MLK Jr. Blvd project will construct a dedicated westbound right turn lane on NE Columbia Blvd. at the intersection of NE MLK Jr. Blvd. and NE Columbia Blvd. A 12-foot City standard sidewalk adjacent to the proposed right turn lane and a new traffic signal will also be constructed.
3. On June 7th, 2017, Council approved Ordinance No. 188428 that approved amendment No. 1 that obligates construction funds for fiscal year 2017-18.
4. This amendment will update the ADA language and milestones so construction funds can be obligated fiscal year 18-19.
5. The Bureau's level of confidence in the cost estimates for this project is high. The project plans have been completed and sent to ODOT for final review. PBOT is expecting to go out to bid as soon as this ordinance is approved.

NOW, THEREFORE, the Council directs:


- a. The Commissioner-in-Charge is hereby authorized to execute an amendment, approved as to form by the city Attorney, with Oregon Department of Transportation for the NE Columbia Blvd at MLK Jr Blvd project, in a form similar to the contract attached as Exhibit A.
- b. The Commissioner-in-Charge is authorized to execute amendments, approved as to form by the City Attorney, to the scope of the services or the terms and conditions of this Agreement, provided the changes do not increase the City's financial risk.

Section 2. The Council declares that an emergency exists because a delay would unnecessarily delay the City's ability to perform the activities authorized by this amendment; therefore, this Ordinance shall be in full force and effect from and after its passage by the Council.
