## ORDINANCE No. 139936

An Ordinance ratifying an agreement with Stephen Swire to operate a concession in O'Bryant Square for calendar year 1975, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds that the Bureau of Parks and the Commissioner of Public Affairs desire to have a concession operation in O'Bryant Square; that on December 30, 1974, an agreement was made with Stephen Swire for such operation by park permit, a copy of which is attached as Exhibit "A"; that this agreement was entered into prior to the implementation of new procedures for concession park permits; and that this agreement should be ratified by the City Council to be valid until December 31, 1975;

NOW, THEREFORE, an agreement with Stephen Swire, 770 Pittock Block, Portland, Oregon 97205, to operate a concession in O'Bryant Square for calendar year 1975 is hereby ratified.

Section 2. Inasmuch as this ordinance is necessary for the immediate preservation of the public health, peace and safety of the City of Portland in this: In order that there may be no undue delay in making arrangements for the concession operation outlined in Section 1 hereof; therefore an emergency hereby is declared to exist and this ordinance shall be in force and effect from and after its passage by the Council.
