- Section 1. The Council finds:
  - 1. ODOT's US26 (Powell Blvd) SE 122nd Ave to SE 136th Ave Project must make necessary adjustments to twelve City of Portland manhole assets.
  - 2. The Bureau of Environmental Services (BES) requested the adjustments be done by ODOT at BES expense as part of said project.
  - The estimated cost is \$12,000.00. Funds are available in the Sewer System Operating Fund, FY 2017-2018 Budget, Bureau of Environmental Services, Internal Order 9ESWW000003.

NOW, THEREFORE, the Council directs:

- a. The Commissioner of Public Affairs is authorized to execute an Add Work Letter Agreement with ODOT for the purposes described in Section 1, in the amount of \$12,000.00, provided the Agreement has been approved as to form by the City Attorney's Office.
- b. The Mayor and Auditor are hereby authorized to draw and deliver warrants chargeable to the Sewer System Operating Fund Budget when demand is presented and approved by the proper authority.
