Purpose of proposed legislation and background information:

The purpose of this legislation is to authorize the Chief Procurement Officer to execute a construction contract for the SE 122nd Ave: Johnson Creek Bridge Replacement Project for \$2,011,712.00.

The project involves replacing the storm-damaged bridge that carries public traffic on SE 122nd Avenue over Johnson Creek. A grant from the Federal Highway Bridge Program to replace the bridge was accepted by Ordinance No. 187976 on September 7, 2016.

The weatherworn timber bridge that carries public traffic on SE 122nd Avenue over Johnson Creek in the Pleasant Valley Neighborhood was significantly damaged by the record-breaking storms in December of 2015. The bridge was closed to all motorized vehicular traffic on February 3, 2016, and remains so.

Ordinance No. 188739 was approved by City Council on December 20, 2017 authorizing the Chief Procurement Officer to issue a competitive solicitation for the SE 122nd Ave: Johnson Creek Bridge Replacement Project on behalf of Portland Bureau of Transportation (PBOT). The construction cost based on bids received is \$2,011,712.00.

No revenues will be impacted by this legislation.

This legislation does not change existing City policy.

Financial and budgetary impacts:

The engineer's estimate for this project was \$2,057,748.07 and the confidence level was High. Based on bids received, the Portland Bureau of Transportation (PBOT) anticipates the construction contract cost to be \$2,011,712.00 which is 2.3% under the engineer's estimate.

Funds are available in PBOT T00574.

No present positions will be created, eliminated or re-classified as a result of this legislation.

Community impacts and community involvement:

The construction contracting community, including contractors certified with the State of Oregon as Disadvantaged, Minority, Women, or Emerging Small Businesses became involved when the Chief Procurement Officer advertised and publicly noticed the project on the City's Online Procurement System on January 19, 2018.

Potential bidders were able to review the competitive solicitation, attend a pre-bid meeting, ask questions, provide comments and submit a bid in response to the Invitation to Bid (ITB). Bids received resulted in the award of the construction contract. Procurement Services managed the procurement process. No protests were received.

We do not anticipate any person or group will be testifying.
