Purpose of proposed legislation and background information:

According to a study by ProPublica, the State of Oregon saw a 60% increase in hate violence in 2016. Here in Portland, our community organizations are a strong resource and refuge for those most targeted by hateful acts. These trusted community organizations fill in gaps that our law enforcement and municipal institutions cannot consistently address, however, they have lacked standardized reporting systems. This gap in city services undermines livability and leave people feeling unsafe.

A pillar of Portland United Against Hate's mission is to address this gap in tracking and response by facilitating a partnership between community organizations and the City of Portland. In 2017, the PUAH Coalition ran a city-funded Pilot Project to begin investigating this issue. The Pilot Project assessed community's experiences with hate incidents and pursued options to provide solutions that would advance safety and healing stemming from hate violence.

The PUAH findings have had a vast impact beyond this small grant: the findings have informed the Coalition's current work and are actively laying the foundation for a forthcoming Hate Incident Reporting System.

Community impacts and community involvement:

The findings and recommendations for next steps detailed in this report are drawn from community focus groups led by seven local organizations, most of which do work with culturally-specific peoples that are often targeted by hateful acts based on their appearance or identity.

The community that provided input into this project is diverse, including people ages 13-66, renters and non-housed people, people from across the gender and sexuality spectrum, and people with disabilities. Most participants were people of color and people who speak a language other than or in addition to English in the home.

The community impact of this project is significant in that it elevates the existing, but untended, experiences of people that experience Portland as an unsafe city. The impact of the Pilot Project has had a lasting effect in providing direction for the coalition's current work, which includes capacity building, training, and data collection.
