

## ORDINANCE No. 188938

\*Authorize a grant agreement with Write Around Portland, in an amount not to exceed \$7,500 for their creative writing for underserved populations program. (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. Write Around Portland believes everyone can be a writer and that our entire community benefits when writers' voices are added to the literary cannon of our city. Since 1999, Write Around Portland has been at the forefront of using art as a means for social change. Based on evaluative research, writing can be a powerful tool for individual and societal transformation; and in every life, there is a vital need for art, community and joy.
2. Through their creative writing for underserved populations program, grantee will hold several creative writing workshops for approximately 100-115 participants at various locations throughout the Metro area including the following locations in Portland: Home Forward for adults living in low-income housing (multiple locations); Morrison Child and Family Services, Shelter Team in Downtown Portland for refugee youth in transition; Donate Life Northwest/Lions Vision Gift in Southeast Portland for adults affected by organ donation; Ron Russell Middle School in Southeast Portland for 6-8th grade students in SUN programming; Whitewood Gardens in Southeast Portland for seniors in assisted living; Oregon Burn Center at Legacy Emanuel Medical Center in North Portland for burn and trauma survivors and their families; Ecumenical Ministries of Oregon, HIV Services in Northeast Portland for long-term HIV survivors; NICU Families NW for families with a child in the neonatal intensive care unit; and Write On for past Write Around Portland workshop participants to learn skills to build their own writing communities.

NOW THEREFORE, The Council directs:

- a. The Director of the Bureau of Revenue and Financial Services, as authorized by Ordinance 188820, is hereby authorized to enter into a grant agreement with Write Around Portland, as outlined in a form substantially in accordance with the agreement attached as Exhibit A, at a cost not to exceed \$7,500.
- b. The Director of the Bureau of Revenue and Financial Services and Auditor are hereby authorized to draw and deliver payment chargeable to Fiscal Year 2017-2018 Budget.

Section 2. The Council declares that an emergency exists because a delay in funding could result in a delay in services; therefore, this ordinance shall be in full force and effect from and after its passage by Council.


