

ORDINANCE No. 188940

*Authorize payment to LTK Consulting Services, Inc. for \$6,348 for operator seat base modification (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. In November of 2017, LTK Consulting Services was asked to provide a proposal for reviewing a Seat Mounting Base Modification for Portland Streetcar.
2. The consultant provided a scope of work and cost estimate of \$6,348 for this work.
3. A Goods & Services Purchase Order was issued and the consultant proceeded with the work.
4. Subsequent review of this purchase determined that it should have followed a Professional, Technical & Expert Services contracting process under City Code 5.68, as the consultant was providing professional advice.
5. The purpose of this Ordinance is to authorize payment to the consultant for work that has been provided to Portland Streetcar in good faith.
6. The Bureau's level of confidence in the cost estimate for these services is high as the work has been completed.


NOW, THEREFORE, the Council directs:

- a. That the Portland Bureau of Transportation is hereby authorized to pay LTK Consulting Services, Inc, for work originally done under DPO 22224935 in an amount not to exceed \$6,348.

Section 2. The Council declares that an emergency exists because the services have been received by Portland Streetcar; therefore, this Ordinance shall be in full force and effect from and after its passage by the Council.
