Subject: Appointments to the Development Review Advisory Committee (DRAC)

Portland City Code Title 3.30.030 specifies that members of the Development Review Advisory Committee (DRAC) may serve up to two 3-year terms. After a thorough review process, I am recommending four candidates for appointment to vacant DRAC positions for 3-year terms running from May 9, 2018 through May 8, 2021:

Shea Flaherty Betin is the Director of Portland Mercado, an arm of Hacienda Community Development Corporation (CDC) that provides professional resources and support to Latino entrepreneurs as they prepare to launch their own businesses.

Paul Delsman is a Senior Project Manager with Bremik Construction, Inc. with almost 25 years' experience in the construction industry, including industrial, retail, and office projects. Paul also serves on the Board of Directors for NAIOP Oregon.

Helen (Holly) Huntley is the founder and owner of Environs LLC, a design/build construction company specializing in responsibly-built accessory dwelling units (ADUs). Holly also teaches in a pre-apprenticeship program for Oregon Tradeswomen, helping other women access careers in the consruction trades.

Lauren Golden Jones is a Commercial Real Estate Development Manager with Capstone Partners. Lauren works with the public and private sectors to develop financing strategies, identify redevelopment sites, and encourage private investment in redevelopment. She also served on the Sullivan's Gulch Neighborhood Association in various capacities from 2008 – 2016.

These four candidates would bring a wealth of expertise and experience to the DRAC. I recommend that Shea, Paul, Holly, and Lauren be appointed to 3-year terms on the DRAC. Their appointments will help ensure that the good work of the DRAC continues on behalf of BDS and other City bureaus, the development industry, and the community.

With these appointments, two vacant positions (Minority Construction Contractors & Development Professionals, and Citywide Neighborhood Interests) would remain on the DRAC. We are currently actively recruiting candidates for those positions. I have enclosed an updated DRAC membership list reflecting these new appointments.
