Purpose of proposed legislation and background information:

The report includes changes to the FY 2018-19 Proposed Budget which must be approved by the City of Portland Budget Committee.

Financial and budgetary impacts:

The action of the Budget Committee (as requested in this report) will increase total requirements in various funds by \$32.4 million from the FY 2018-19 Proposed Budget, as distributed on May 7, 2018. In total, a net of 20.58 positions are increased in the FY 2018-19 Approved Budget.

Community impacts and community involvement:

The Approved Budget includes multiple programmatic changes that will impact the community. A five-member Community Budget Advisory Board was invited to sit in on budget discussions with the Mayor and Council as the budget was developed. In addition, numerous public hearings and forums were held throughout the budget process. Public testimony on the budget was accepted in person, in writing, and via email.

ADA Compliance CAL Adjustment

If approved, this funding will be dedicated to ADA compliance in each bureau.

Business License Tax
