FY 2018-19 Budget Summary

The BES requested budget—

 - Community relationships
- Advances CIP planning and delivery improvements
- Manages responsibly by targeting rate increases of 3.0% or lower



Environmental Services FY 2018-19

Proposed Budget — \$536.4 million

\$28.3 million **GF Central Services**, **Utility License Fee, Pension Obligation Bonds** \$139.1 million **Operations and Maintenance** (including Portland Harbor Superfund) \$180.7 million **Debt Service** \$55.0 million **Cash Funding of Capital Improvements and Rate Stabilization Transfers**





Residential Rates


Average single-family\$100residential monthly\$90sewer and stormwater\$80bill increases\$70by \$1.69 (2.35%).\$60






Historical & Projected Bill Increases

Percentage Increases in Average Monthly Residential Bills



Assistance Programs

- Qualifying low-income customers will receive a discount of \$32.43 per month
 - Approx. 6,600 on program currently
 - Program expansions expected beginning in FY2018-19
 - Adds extremely low-income discount of \$51.89
 - Increase the crisis voucher from \$150 to \$500.
 - Establish multi-family low-income crisis assistance
- Clean River Rewards Stormwater Discount Program
 - Approx. 35,000 participating accounts
 - Typical monthly discount of approximately \$10 (average single family residential)



SDC and Connection Charges

• SDC rate components increase

Example 1: Combined SDC for a single-family residential dwelling increases by 5.7% Example 2:

Combined SDC for an industrial park with 2 large buildings increases by 1.6%

• Connection Charges increase by an average of 3.2%



Permits, Fees and Other Charges

- Building Plan Review Fees increase by an average of 4.5%
- Land Use Review Fees increase by an average of 7.7%
- Two new Land Use Review fees
 - Central City Master Plan Review
 - Planned Development Bonus Review
- Street Use Permit Fees increase by an average of 2.3%
- Source Control and Stormwater Management Manual
 Fees are unchanged

Typical Single-family Residential Water and Sewer/Stormwater Monthly Bill
