

ORDINANCE No.

*Pay property damage claim of Nguyet Le in the sum of \$25,514 involving the Portland Police Bureau (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. Nguyet Le has filed a property damage claim against the City for damages to her rental house that resulted from actions of the Portland Police Bureau on September 8, 2016.
2. The claim has been investigated by Risk Management Services and the City Attorney's Office. The investigation indicates there is a risk the City may be found liable. In addition, the Committee on Claims has recommended payment. Therefore, we feel it is prudent to compromise the claim at this time.
3. The City Attorney's Office recommends the claim be compromised for the total sum of \$25,514, subject to the claimant providing the City with a release in a form to be approved by the City Attorney.

NOW, THEREFORE, the Council directs:

- a. The Mayor and the Auditor are hereby authorized to draw and deliver a check in the amount of \$25,514 made payable to Nguyet Le.
- b. Risk Management Services will execute a payment authorization in the amount set forth in sub-paragraph (a) above.

Section 2. The Council declares that an emergency exists in order to avoid undue and costly delay in settling this property damage claim; therefore, this Ordinance shall be in full force and effect from and after its passage by the Council.
