TO THE COUNCIL:

The Bureau of Environmental Services (BES) has a need for temporary, supplemental personnel for construction management, inspection, and project support on an as-needed basis for peak workload periods for the bureau's Capital Improvement Program (CIP), for projects including storm and sanitary sewers, wastewater pump stations, wastewater treatment facilities, storm water treatment facilities and drainageway improvements.

The estimated cost for these services over a period of five (5) years is approximately \$25,000,000.

On September 13, 2017, City Council passed Ordinance No. 188599 authorizing a competitive solicitation for the purchase of construction management, inspection, and project support personnel services for an estimated amount of \$25,000,000.

On December 12, 2017, the Chief Procurement Officer advertised RFP No. 00000801 and six (6) proposals were received and opened on January 9, 2018. All proposals were deemed responsive to the requirements of the solicitation. The proposals were evaluated and scored by a panel of evaluators including a member of the Minority Evaluator Program. The City issued a Notice of Intent to Negotiate and Award price agreements to the following firms, on April 6, 2018, and no protests were received.

All four (4) of the firms to be awarded contracts are State of Oregon, COBID certified firms, have current business tax registrations, and are in compliance with all of the City's contracting requirements. The Bureau's level of confidence in the cost estimate for this agreement is "High" as there is good historical information regarding purchases made for these services.

Awarding a price agreement to these firms will allow the City to continue work in areas where staffing limitations exist and continue to provide excellent service to customers and the public. It is requested that City Council authorize the Chief Procurement Officer to execute price agreements with Allen Construction Management Services, LLC, EMTS, LLC, DRW, LLC, and Exeltech Consulting, Inc., for a combined notto-exceed amount of \$25,000,000.
