

## ORDINANCE NO. 188969

Extend grant agreements by one year and provide additional grant funding not to exceed \$350,000 in aggregate, with seven organizations providing services to youth in partnership with Portland Parks & Recreation (Ordinance; amend Contract Nos. 3005318, 3005319, 30005362, 30005363, 30005364, 30005366, 30005367)

The City of Portland ordains:

Section 1. The Council finds:

1. In 2015, the Portland Police Bureau reported 183 gang shootings in our community. In FY 2015-16, City Council appropriated funds to support an expansion of pro-social activities for at-risk youth in safe and supportive environments. This expansion in services included an emphasis on collaborative partnering with youth-serving organizations.
2. In 2016, Ordinance 187884 approved grants for \$50,000 per year for two years to each of the following organizations (collectively, the Grant Agreements):
  - Portland Opportunities Industrialization Center (POIC),
  - Immigrant & Refugee Community Organization (IRCO) - Africa House
  - Latino Network
  - Native American Youth and Family Center (NAYA)
  - Boys & Girls Club of Portland Metropolitan Area (BGC)
  - Self Enhancement, Inc. (SEI)
  - REAP, Inc.
3. The Grant Agreements expire June 30, 2018. During FY 2018-19, PP&R intends to review and improve the overall process of soliciting and awarding grants to be implemented in grant agreements commencing July 1, 2019.
4. PP&R proposes to extend the current grants for FY 2018-19 while that process redesign is underway. The intent of the extension is to maintain the current level of service with these partners with generally similar scopes of work and funding levels (\$50,000 for each of the seven partners) for one year, expiring June 30, 2019.

NOW, THEREFORE, the Council directs:

- a. The Director of Portland Parks & Recreation is authorized to amend the Grant Agreements with Portland Opportunities Industrialization Center (POIC), Immigrant & Refugee Community Organization (IRCO) – Africa



House, Latino Network, Native American Youth and Family Center (NAYA), Boys & Girls Club of Portland Metropolitan Area, Self-Enhancement, Inc. (SEI), and REAP Inc. in a form substantially similar to those found in Exhibits A-G. All amendments shall be approved as to form by the City Attorney.

- b. The Director and City Auditor are hereby authorized to pay the grant amounts stated in the amendments to the extent such funds have been allocated in PP&R's budget.
