# Purpose of proposed legislation and background information:

In 2015, the Portland Police Bureau reported 183 gang shootings in our community. In FY 2015-16, City Council appropriated funds to support an expansion of pro-social activities for at-risk youth in safe and supportive environments. This expansion in services included an emphasis on collaborative partnering with youth-serving organizations.

In 2016, Ordinance 187884 approved grants for \$50,000 per year for two years to each of the following organizations (collectively, the Grant Agreements):

- Portland Opportunities Industrialization Center (POIC),
- Immigrant & Refugee Community Organization (IRCO) Africa House
- Latino Network
- Native American Youth and Family Center (NAYA)
- Boys & Girls Club of Portland Metropolitan Area (BGC)
- Self Enhancement, Inc. (SEI)
- REAP, Inc.

The Grant Agreements expire June 30, 2018. During FY 2018-19, PP&R intends to review and improve the overall process of soliciting and awarding grants to be implemented in grant agreements commencing July 1, 2019.

PP&R proposes to extend the current grants for FY 2018-19 while that process redesign is underway. The intent of the extension is to maintain the current level of service with these partners with generally similar scopes of work and funding levels (\$50,000 for each of the seven partners) for one year, expiring June 30, 2019.

## Financial and budgetary impacts:

For Fiscal Year 2018-19, the aggregate amount of grant funding that will be allocated to selected organizations is not to exceed \$350,000. These funds are built into the Teen Program's ongoing budget.

### Community impacts and community involvement:

The overall framework for the teen program partnership was shaped through meetings with community stakeholders held during Fiscal Year 2014-15. Community stakeholders included representatives from large and small youth serving non-profits, other government agencies, private citizens, and other bureau representatives.

Beginning in 2015, PP&R has expanded its impact on serving teens through grants to partners including the Boys and Girls club, Immigrant &refugee Community Organization (IRCO), Latino Network, Self Enhancement, Inc, Native American Youth Association, REAP, and Portland Opportunities Industrial Center (POIC). New grant proposals were solicited from these organizations in 2016, and two-year grants were awarded based on that process.

PP&R intends to review and improve the process of soliciting and awarding grants to youth-serving organizations in FY 2018-19. Stakeholders will be involved in shaping those improvements.
