

## ORDINANCE No. 189011

\*Authorize a grant agreement with Planned Parenthood Columbia Willamette, in an amount not to exceed \$25,000 for their health literacy program. (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. The mission of Planned Parenthood is to provide, promote, and protect access to sexual and reproductive health care. They believe that health literacy and sex education provides knowledge, support and resources for youth to develop healthier relationships, delay sexual initiation, decrease sexually transmitted infections (STIs) and unplanned pregnancies.
2. Planned Parenthood Columbia Willamette's (PPCW) health literacy program covers the entire school year in Portland high schools. On average 15-20 youth are enrolled in the program. Twenty-eight classroom educational sessions are conducted, and the youth provide outreach to approximately 4,000 additional participants each school year; including other students and family members. Offered free of charge, PPCW's Teen Council utilizes an evidence-based curriculum called Making Proud Choices, which engages youth between the ages of 13-18 years in experiential learning. Through sustained relationships with Portland schools, Planned Parenthood Columbia Willamette's (PPCW) peer-led Teen Council program, aligned with the goals of the State of Oregon's Youth Sexual Health Plan, helps reduce disparities faced by underserved communities and LGBTQ youth.

NOW THEREFORE, The Council directs:

- a. The Director of the Bureau of Revenue and Financial Services, as authorized by Ordinance 188820, is hereby authorized to enter into a grant agreement, with Planned Parenthood Columbia Willamette as outlined in a form substantially in accordance with the agreement attached as Exhibit A, at a cost not to exceed \$25,000.
- b. The Director of the Bureau of Revenue and Financial Services and Auditor are hereby authorized to draw and deliver payment chargeable to Fiscal Year 2017-2018 Budget.

Section 2. The Council declares that an emergency exists because a delay in funding could result in a delay in services; therefore, this ordinance shall be in full force and effect from and after its passage by Council.
