ORDINANCE No. 189020 As Amended

*Authorize the renaming of SW Stark Street to SW Harvey Milk Street in the City of Portland (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

- 1. On February 1, 2018, the Harvey Milk Street Project Committee submitted an application to rename SW Stark St to SW Harvey Milk St to the City Engineer at the Portland Bureau of Transportation.
- 2. On February 7, 2018, City Council passed Ordinance 188808 to waive Portland City Code Subsection 17.93.020 in order for this application to move forward in good faith to rename only SW Stark St and not Stark Street throughout the City.
- 3. On February 7, 2018, the City Engineer provided applicants with official petition forms as outlined in City Code Subsection 17.93.030.
- 4. On March 1, 2018, applicants submitted over 2,800 signatures from legal residents of the City at large, as required by City Code Subsection 17.93.030.
- 5. On March 5, 2018, Commissioner Dan Saltzman, Commissioner-in-Charge of the Portland Bureau of Transportation, appointed Darcelle XV, aka Walter Cole, Cindy Cumfer, Kathleen Saadat, and Kerry Tymchuk to a four-member Historian Panel as outlined in City Code Subsection 17.93.040.
- 6. On March 23, 2018, the Portland Bureau of Transportation accepted and completed the checklist for the Final Application Packet.
- 7. On April 2, 2018, the Historian Panel held a public meeting to discuss the application, the proposed honoree and location, as well as the proposed street's current namesake: Benjamin Stark. The Panel elected Kerry Tymchuk as Chair, voted unanimously to recommend that Harvey Milk was an appropriate honoree to have a city street renamed in his honor and that SW Stark St was an appropriate location.
- 8. On April 2, 2018, the City Auditor conducted a postcard mailing survey to all legal owners and legal addresses on or abutting SW Stark St as outlined in City Subsection 17.93.040.

- 9. On April 24, 2018, the Historian Panel sent a letter of recommendation to the Planning & Sustainability Commission as outlined in City Code Subsection 17.93.040.
- 10. On April 30, 2018, the Portland Bureau of Transportation submitted a budget impact statement to the Planning & Sustainability Commission as outlined in City Code Subsection 17.93.040.
- 11. On May 7, 2018, the City Auditor forwarded the tabulated responses of their postcard survey to the Planning & Sustainability Commission as outlined in City Code Subsection 17.93.040.
- 12. On May 15, 2018, the Planning & Sustainability Commission conducted a public hearing on the street renaming application as outlined in City Code Subsection 17.93.040.
- 13. On June 1, 2018, the Planning & Sustainability Commission submitted its letter of recommendation to Portland City Council.
- 14. Attached as Exhibit A is the original street renaming application; Exhibit B is Ordinance 188808; Exhibit C is a sample petition form provided to the applicants; Exhibit D is the memo to appoint the Historian Panel; Exhibit E is the Final Application Packet checklist from the Portland Bureau of Transportation; Exhibit F is the recommendation letter from the Historian Panel; Exhibit G is the Budget Impact Report from the Portland Bureau of Transportation; Exhibit H is the memo from the City Auditor with the results of their postcard survey; and Exhibit I is a letter of recommendation from the Planning & Sustainability Commission.

NOW, THEREFORE, The Council directs:

- a. Southwest Stark Street shall be renamed as Southwest Harvey Milk Street.
- b. The Auditor shall notify owners and occupants of all property abutting the street being named, affected public agencies, the general public, US Post Office, and emergency service organizations of the name change through public notice, direct correspondence, and other appropriate means.
- c. The Portland Bureau of Transportation shall install new street signs showing the new street name alongside the existing name signs and shall maintain both sets of signs for a period of five years at the level of maintenance approved for street name signs city-wide.

d. At the end of the five years, the Portland Bureau of Transportation shall remove the Southwest Stark Street signs.

Section 2. The Council declares that an emergency exists because it is Pride Month and the Pride Parade is this weekend and we want to celebrate and honor Harvey Milk with a street being renamed Harvey Milk today; therefore, this ordinance shall be in full force and effect from and after its passage by the Council.
