Purpose of proposed legislation and background information:

Multnomah County, the City of Gresham and the City of Portland desire to enter into agreements to provide financial support to Portland for taking lead responsibility for staffing and support for a quarterly multi-jurisdictional Fair Housing committee, jurisdictional stakeholder meetings, as well as leading the coordination and production of the new five year 2016-2020 Consolidated Plan, annual Action Plan fiscal year 2018-2019, Analysis of Impediments to Fair Housing, updates and other plans and performance reports as requested of the Consortium by HUD.

Financial and budgetary impacts:

Multnomah County and the City of Gresham have agreed to reimburse PHB \$3,500 and \$10,000, respectively in CBDG for FY 2018-2019 for coordination of the 2016-2020 Consolidated Plan Amendments, updates to the Analysis of Impediments to Fair Housing Action Plan, and Action Plans FY 2018-2019. These amounts were included in PHB's FY 2018-19 base budgets. These amounts are made annually for the annual Consolidated Plan activities. The City will not incur any additional costs. CDBG is the source of funding for the expenses of preparing the FY 2016-2020 Consolidated Plan Amendments, updating the Analysis of Impediments to Fair Housing Action Plan, and preparing the Action Plans FY 2018-2019 and any amendments to the five-year FY 2016-2020 Consolidated Plan, were included in PHB's base budget for FY 2018-19. This action does not change staffing.

Community impacts and community involvement:

Future public involvement is not anticipated for this item because there is already an agreement to accept the funds. The funds do contribute to public participation efforts to involve the public in the Consolidated Planning process and annual Action Plans. The public is invited through several annual hearings and quarterly Fair Housing Advocacy Committee meetings.

100% Renewable Goal:

This action provides for the City of Portland to coordinate with the City of Gresham and Multnomah County to write community plans. These plans do address offering energy efficiency measures to low-income homeowners. However, the plans do not directly result in the use of renewables, thus this action does not fall under the City's goal of meeting 100 percent renewable energy.
