# Origin of Map Refinement Project

In response to December 2016 City Council directive to explore additional Comprehensive Plan and Zoning Map changes (Exhibit O of Ordinance No. 188177)

## Exhibit O – Further Refinement Directive

The Bureau of Planning and Sustainability is directed to evaluate the Comprehensive Plan designation and zoning of the following sites, and bring appropriate recommendations back to Council for further consideration.

- a) 7008 SW Capital Hill Rd
- b) 9808 N Edison St
- c) 4931 – 4947 N Williams Ave
- d) The Marquam Hill mixed use node  
(multiple parcels)
- e) 4836 SE Powell Blvd
- f) 310 NW 23rd Ave
- g) 4337 NE Prescott St
- h) 4543 SE Harney Dr
- i) 5727 SE 136th
- j) 506 NE Thompson
- k) 25 N Fargo Street
- l) 3138 W/N Vancouver Avenue
- m) 2525 NW Lovejoy Street  
(and several abutting lots in medical office use).











# Early Testimony Preview

- New requests
- Removal of the Buffer “b” Overlay zone on Employment and Industrial zoned areas
- CM2d to CM3d zoning recommendation on Fremont and Mississippi
- Sites included in the Proposed Draft (September 2017) that generated public comment



# Process update

- Discussion Draft
  - 53 public comments (June 15 - July 31)
- Proposed Draft
  - 176 items of public testimony (Sept. 12 - Oct. 27)
- Recommended Draft
  - Publicly released and Map App live on Feb. 5
  - Public notices mailed starting on Feb. 16



# Next steps - Map Refinement Project

- March 14 - City Council public hearing
- \*April 4 (tentative) - City Council deliberation
- May 24 - City Council vote
- May 24 - Effective date of map changes
