

**ORDINANCE No. 189058**

\*Pay claim of Claudiu Milea in the sum of \$10,000 for bodily injuries sustained in a motor vehicle collision involving Portland Police Bureau (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. Claudiu Milea, through attorney Charles Harms, has filed a claim against the City for bodily injuries sustained in a motor vehicle collision involving the Portland Police Bureau on Thursday, May 25, 2017.
2. The claim has been investigated by Risk Management Services. The investigation indicates there is risk the City may be found liable. Therefore, in order to avoid the risk of an adverse jury award, we feel it is prudent to compromise the claim at this time.
3. Risk Management Services recommends the Claim be compromised for the total sum of \$10,000, subject to the claimant providing the City with a release in a form to be approved by the City Attorney.

NOW, THEREFORE, the Council directs:

- a. The Mayor and the Auditor are hereby authorized to draw and deliver a check in the amount of \$9,198.31 made payable to Attorney Charles Harms and his client Claudiu Milea.
- b. The Mayor and the Auditor are hereby authorized to draw and deliver a check in the amount of \$801.69 made payable to the Treasurer of the United States.
- c. Risk Management Services will execute a payment authorization in the amount set forth in sub-paragraphs (a) and (b) above.


