

ORDINANCE No. 189099

- * Authorize Intergovernmental Agreement with the City of Hillsboro for Hillsboro Fire Department to use a reserve aerial ladder truck from Portland Fire & Rescue (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. Portland Fire & Rescue (PF&R) and Hillsboro Fire Department are mutual aid departments.
2. Hillsboro's frontline aerial ladder truck has suffered catastrophic engine failure and will be out of service for repairs for several months, forcing Hillsboro to deploy their only reserve truck.
3. With Hillsboro's sole reserve truck in-service while their frontline truck is being repaired, Hillsboro will not have an aerial ladder truck available to serve the public in case a failure occurs to their reserve truck.
4. Portland Fire & Rescue (PF&R) owns several reserve fire trucks and can loan Hillsboro one of those reserve fire trucks.
5. During the term of the agreement, PF&R will have the sole discretion to grant or deny Hillsboro's request to borrow a fire truck.
6. Hillsboro will be responsible for repair and maintenance of the reserve fire truck while in their possession, and Hillsboro will return the truck to PF&R immediately if PF&R has an emergency situation that would require the use of the truck.
7. A sharing of resources by Hillsboro and PF&R improves the level of emergency response that is available to the residents and visitors experiencing an emergency.
8. This agreement will last for five years and the lending of a reserve truck will occur on an as-needed basis to allow PF&R to quickly assist Hillsboro if a similar situation arises in the future.
9. The provisions of ORS 190.010 authorize the City to enter into this agreement with the City of Hillsboro.


NOW, THEREFORE, the Council directs:

- a. That the Commissioner in Charge and City Auditor are authorized to execute an intergovernmental agreement with the City of Hillsboro in a form substantially similar to the agreement attached as Exhibit A.

Section 2. The Council declares that an emergency exists because it is in the interest of fire and life safety to the residents and visitors of Hillsboro that Hillsboro has a backup aerial ladder fire truck immediately available in case their only operational fire truck has a failure. Therefore, this ordinance shall be in full force and effect from and after its passage by the Council.
