

## ORDINANCE No. 189104

\*Pay personal injury lawsuit of Anthony Allen in the sum of \$25,000 involving the Portland Police Bureau (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. Anthony Allen, through attorney Ashlee Albies, has filed a personal injury lawsuit against the City for damages suffered when he was arrested by the Portland Police Bureau on May 18, 2015.
2. The claim has been investigated by Risk Management Services and the City Attorney's office. The investigation indicates there is risk the City may be found liable for damages. Therefore, in order to avoid future litigation costs and the risk of an adverse jury award, we feel it is prudent to compromise the lawsuit at this time.
3. Risk Management Services recommends the lawsuit be compromised for the total sum of \$25,000, subject to the claimant providing the City with a release in a form to be approved by the City Attorney.


NOW, THEREFORE, the Council directs:

- a. The Mayor and the Auditor are hereby authorized to draw and deliver a check in the amount of \$25,000 made payable to Albies & Stark, LLC in Trust for Anthony Allen.
- b. Risk Management Services will execute a payment authorization in the amount set forth in sub-paragraph (a) above.


