There has been destruction of trees and Water Bureau and private property, as well as dozens of abandoned cars and vehicles, thousands of needles requiring hazardous material teams, some violence and a dramatic increase in car thefts, break-ins, burglaries, and trash. While some of these neighbors have been active in UPNA activities and meetings, others have accosted Peninsula Crossing Trail users and local school students. The UPNA requests that the Council direct the Housing Bureau to maintain and secure this

property promptly and diligently, to include the neighbors in this process and to report back to the Commissioner and Council.

The UPNA requests that the Housing Bureau be directed to create a task force or advisory committee with the neighborhoods, recreational trail users, and house-less residents along with the other property owners (PGE, BNSF, ODOT and private owners) and Fire and Police Bureaus and County Health to address concerns and to develop effective mechanisms for persons to gain access to permanent housing, health care and treatment and to protect the environment and persons.

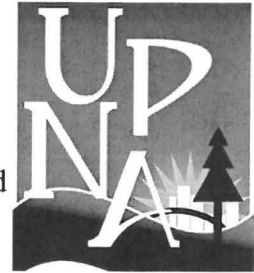
