*Authorize an Intergovernmental Agreement between the Portland Housing Bureau and Portland State University to fund a Graduate Research Assistant to work with the Portland Housing Bureau (Ordinance)

PHB of Portland ordains:

Section 1. The Council finds:

- 1. PSU and PHB desire to conclude an Intergovernmental Agreement (hereinafter "Agreement") to establish the terms and conditions of cooperative interaction between the parties to provide funding for a Graduate Research Assistant who will work with the Portland Housing Bureau.
- 2. Collaboration with PSU on selecting and funding Graduate Research Assistants benefits PHB through research and project assistance from qualified Master of Urban and Regional Planning students with diverse experiences and perspectives, to aid PHB in researching and developing housing policy and programming.

NOW, THEREFORE, the Council directs:

- a. The Director of the Portland Housing Bureau is hereby authorized to execute an intergovernmental agreement with Portland State University in a form substantially similar to the agreement attached as Exhibits A.
- b. The Director of the Portland Housing Bureau is hereby authorized to sign amendments for continuing data management, reporting and funding in future fiscal years if appropriations are approved by City Council.

Section 2. The Council declares that an emergency exists because delay would impede the selection process and work of the student researcher within the academic year; therefore, this Ordinance shall be in full force and effect from and after its passage by the Council.
