

## ORDINANCE No. 189200

\*Amend contract with Trauma Intervention Programs Portland/Vancouver Inc. in the amount of \$414,033 to provide emergency emotional crisis intervention services for an additional five years (Ordinance; amend Contract No. 30003584)

The City of Portland ordains:

Section 1. The Council finds:

1. On December 1, 2013 a contract was entered into between the City of Portland (City) and Trauma Intervention Programs Portland/Vancouver Inc. (TIP) to provide emergency emotional crisis intervention to victims, family members, and bystanders involved in emergency response incidents.
2. Providing immediate on-scene crisis services to emotionally traumatized persons is sensitive work and requires the use of an organization with the highest quality standards and proven track record. TIP is a nationally recognized leader in providing volunteer emergency support services.
3. The original Contract was awarded as a result of the City's competitive solicitation FIR045, posted on the City website on June 10, 2013. In addition, PF&R sent email notices to 13 mental health/crisis counselors listed in the Oregon State Minority/Women Owned/Emerging Small Business database.
4. The solicitation closed at 4:00 p.m. on June 28, 2013 and two proposals were received. Review of the proposals was conducted by an evaluation committee of five members consisting of three PF&R employees and two community members including one Minority Evaluator Program member. The ethnic makeup of the committee included an African American, an Asian American and a Native American. The evaluation committee identified TIP as the highest scored proposer.
5. The executive director of TIP is a half-time City employee. The City employee had no influence, direct or indirect, in the development of the competitive solicitation, decision regarding the award or negotiating the contract on behalf of the City. In accordance with PCC 5.33.070, Council approved Ordinance 186304 to authorize Contract No. 30003584 in which a City employee is associated.
6. The original Contract amount was \$390,000 with a five-year term and an expiration date of November 30, 2018.
7. Due to the on-going need for trauma intervention services as provided by TIP, PF&R recommends that Contract No. 30003584 with Trauma Intervention

Programs Portland/Vancouver Inc. be amended to increase the compensation by \$414,033.44 and extend the expiration date an additional five years to November 30, 2023.

8. In accordance with PCC 5.68.035(B), Council approval is required to authorize a PTE contract amendment when the amendment would exceed 25 percent of the original contract amount.
9. The expense is included in PF&R's budget beginning in FY 2018-19.
10. Previous Amendments: NONE

NOW, THEREFORE, the Council directs:


- a. The Commissioner-in-Charge is authorized to amend Contract No. 30003584 with Trauma Intervention Programs Portland/Vancouver Inc. in a form substantially similar to the amendment attached as Exhibit A.
- b. The Mayor and the Auditor are hereby authorized to draw and deliver checks payable to Trauma Intervention Programs Portland/Vancouver Inc. chargeable to Portland Fire & Rescue when demand is presented and approved by the proper authorities.

Section 2. The Council declares that an emergency exists to prevent an interruption in emotional crisis intervention services. Therefore, this ordinance shall be in full force and effect from and after its passage by the Council.


