

ORDINANCE NO. 189216

Authorize Intergovernmental Agreements and grant agreements in support of the Lead Hazard Reduction Program for five years beginning FY 2019-20 in an amount up to \$425,000 per year and increase the annual not to exceed authorized amount for FY 2018-19 to \$395,000 (Ordinance; amend Ordinance No. 186628)

The City of Portland ordains:

Section 1. The Council finds:

1. The Water Bureau funds community partner and agency programs for education, outreach, testing, and remediation programs for lead poisoning prevention as part of the Lead Hazard Reduction Program.
2. The Lead Hazard Reduction Program has four components: water treatment and monitoring; home lead reduction; lead-in-water education and testing; and education and outreach. The Water Bureau funds education and outreach programs for lead poisoning prevention through community partner programs.
3. Since 1997, the Lead Hazard Reduction Program has been deemed “optimized treatment” to comply with the Environmental Protection Agency’s Lead and Copper Rule for drinking water. The Lead Hazard Reduction Program increases awareness of lead hazards from all sources, recognizing that lead in housing is a greater contributor to childhood lead poisoning.
4. The Water Bureau is in the process of implementing improved corrosion treatment for lead in water. Until improved treatment is installed, the Lead Hazard Reduction Program will continue as the Water Bureau’s compliance with the Lead and Copper Rule.
5. Ordinance No. 186628 authorized the Water Bureau Administrator to execute agreements, not to exceed \$375,000 per fiscal year, in support of the Lead Hazard Reduction Program through FY 2018-19. The Water Bureau requires additional authorization to increase the annual not exceed authorized amount for FY 2018-19 to \$395,000.
6. Continued recognition of the Lead Hazard Reduction Program is important; therefore, the Water Bureau will be requesting additional funding of up to \$425,000 per year in the FY 2019-20 through FY 2022-23 budgets to execute grants and agreements to our partners.
7. Partners are chosen by a selection committee consisting of representatives from the Oregon Health Authority Lead Poisoning Prevention Program, Portland Housing Bureau, and the Water Bureau. All partners will have to enter into a formal agreement executed by the Water Bureau to receive funding.

8. Examples of lead poisoning prevention programs selected for funding in the past have included the Multnomah County Health Department to implement the LeadLine referral program and to provide free blood lead testing for children; Community Energy Project to provide workshops on lead poisoning prevention activities and lead-safe projects that individuals can do in their own home; Growing Gardens to provide soil testing for lead in gardens and yards; the Community Alliance of Tenants to provide tenants with lead poisoning prevention information; Fair Housing Council of Oregon to provide lead hazard education and outreach to landlords; and Portland Public Schools to remediate lead paint hazards in early education facilities.
9. The Water Bureau has approved budget of \$395,000 for the FY 2018-19 Lead Hazard Reduction Program. Additional funding of up to \$425,000 per year will be requested in the FY 2019-20 through FY 2022-23 budgets for the Lead Hazard Reduction Program.

NOW, THEREFORE, the Council directs:

- a. The Water Bureau Administrator is authorized to execute agreements in FY2018-19 substantially in accordance with Exhibit B (Intergovernmental Agreement) in support of the Lead Hazard Reduction Program. The combined annual agreements will not exceed \$395,000.
- b. The Water Bureau Administrator is authorized to execute agreements in FY 2019-20 through FY 2022-23 substantially in accordance with Exhibit A (Grant Agreement) and Exhibit B (Intergovernmental Agreement) in support of the Lead Hazard Reduction Program when funds are allocated by City Council and included in the Water Bureau's approved budget. The combined annual agreements will not exceed \$425,000 per fiscal year.
- c. Amendments increasing the total compensation for said agreements and grants may be agreed to and executed by the Portland Water Bureau Administrator up to twenty-five percent of the total grant or agreement amount. Any increase exceeding twenty-five percent of the total compensation would need City Council approval.
- d. All agreements authorized by this ordinance are subject to approval as to form by the City Attorney's Office.
- e. The Mayor and Auditor are hereby authorized to draw and deliver checks chargeable to the Water Fund when demand is presented and approved by the proper authorities.
