

ORDINANCE No. 189222

- * Authorize Intergovernmental Agreement with Portland State University to perform data analysis, community outreach, strategic development, and create Blueprint for Success reports to proactively address community needs at a not-to-exceed amount of \$21,000 (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. Portland Fire & Rescue's mission is to proactively, safely, and aggressively protect life, property, and the environment. To help fulfil this mission, PF&R is working to evolve its service delivery model beyond a reactive, emergency response model and towards a more proactive model.
2. The Blueprint for Success was created as a planning tool to identify risks within each Fire Management Area (FMA) and to outline strategies for improving services and outcomes. PF&R's goal is to tailor our responses, prevention, and education efforts to match the individual needs of each community before they become worst-case scenarios where a 9-1-1 call must be made.
3. In 2017, PF&R partnered with Portland State University (PSU's) Masters of Urban and Regional Planning program to launch a Blueprint for Success pilot for Fire Station 22. Over the course of a year, PSU conducted interviews, led focus groups, created and dispersed a community-wide survey, conducted data analysis, and created a comprehensive Blueprint for Success report.
4. The FMA 22 blueprint cannot be universally applied across all of PF&R's FMAs because each FMA is unique in demographics, resources, risks, topography, traffic patterns, building density, land use, etc. For this reason, each FMA must be analyzed individually and planned for accordingly.
5. PSU's School of Urban Studies & Planning has the capability to create additional Blueprint for Success reports for PF&R's other FMAs. Performance of this scope of work is consistent, compatible, and beneficial to the academic role and mission of PSU.

NOW, THEREFORE, the Council directs:

- a. That the Commissioner-in-Charge and the Auditor are authorized to enter into an Intergovernmental Agreement with Portland State University substantially in accordance with the agreement attached to the original of this ordinance and, by reference, made a part hereof. (Exhibit A)


