

## ORDINANCE No. 189223

Accept a grant in the amount of \$105,060, appropriate \$35,000 for FY 2018-19, and authorize an Intergovernmental Agreement with Multnomah County for the Domestic Violence Enhanced Response Team to be partially reimbursed for a Police Bureau sergeant through September 30, 2020 (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. The Multnomah County Family Violence Coordinating Council partners applied to the Department of Justice (DOJ) Office on Violence Against Women (OVW) FY17 Grants to Encourage Arrest Policies and Enforcement of Protection Orders (GTEAP) program for a grant in the amount of \$750,000 for the Domestic Violence Enhanced Response Team (DVERT) program;
2. The OVW's Improving Criminal Justice Responses Program is designed to encourage partnerships between government agencies, victim service providers, coalitions, and rape crisis centers, to ensure that sexual assault, domestic violence, dating violence, and stalking are treated as serious violations of criminal law;
3. Multnomah County Department of County Human Services (DCHS) has notified the City that it will award \$105,060 to the City for Police Bureau participation in the DVERT program;
4. The purpose of Intergovernmental Agreement (IGA) MC #44-3904 is to provide funds to the City and obligate agency roles and responsibilities;
5. The IGA stipulates Multnomah County will reimburse the City for 25 percent of the payroll expenses for the Police Bureau DVERT Sergeant through September 30, 2020;

NOW THEREFORE, The Council directs:

- a. The Mayor is hereby authorized to accept on behalf of the City a grant from DCHS for the OVW FY17 GTEAP program in the amount of \$105,060 and to execute the grant agreement and to execute an intergovernmental agreement in a form similar to the agreement attached as Exhibit A.
- b. The FY 2018-19 budget is hereby amended as follows:



- c. The Office of Management & Finance Grants Management Division is authorized to perform all administrative matters in relation to the grant application, grant agreement or amendments, requests for reimbursement from the grantor, and to submit required online grant documents on the Mayor's behalf.
- d. The Chief of the Police Bureau, or the grant project manager, is authorized to accept on behalf of the City any subsequent modifications by DCHS for the OVW FY17 GTEAP DVERT grant, #2017-WE-AX-0011, provided such modifications do not increase the City's financial obligation or risk. Any modifications that increase the City's financial obligation or risk must be authorized by Council.
