

The Couch Hotel was formerly operated by HACHISUKE and HAZUE UYESUGI (Japanese) and when they were evacuated this hotel was operated by CLARENCE E. and CORA OLIVER who were very friendly to many of our local Japanese families. Their lease expired on Dec.31,1944 and the present petitioners Mr. and Mrs. Alfred A. Minx assured me that

there would be no Japanese connection in the management of the hotel.

Mr.Alfred A.Minx was formerly the plant Supt., at the Keystone Press and his wife Sue is presently the secretary of the Kellog Chapter # 157, Order of the Eastern Star. She is also the niece of the late Mr. Pike of which the Couch Hotel is part of the estate.
