The City of Portland ordains:

Section 1. The Council finds:

- 1. Ordinance No. 172614, passed by the Council on August 19, 1998 and effective as of October 1, 1998, authorized establishment of a Parks and Recreation System Development Charge (SDC) and created a new City Code Chapter 17.13.
- 2. Since it was created, Chapter 17.13 has been updated, in ordinances 172732, 172758, 173386, 173565, 174617, 176511, 176955, 179008. 181669, 183447, 183448, 187150, and most recently in 189050, effective August 1, 2018.
- Portland Parks & Recreation has proposed further updates to City Code 3. Section 17.13 to improve and clarify implementation of the SDC Program.
- 4. It is in the best interest of the people of the City of Portland to adopt this Ordinance.
