ORDINANCE No. 189307

*Authorize an Intergovernmental Agreement with Parkrose School District for \$10,000 for the Parkrose-Argay Development Study known as Rossi Farms Development Plan (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. In June 2017, the Bureau of Planning and Sustainability (BPS) applied for a Metro grant of \$112,500 to support drafting the Rossi Farms Development Plan (Plan); the Plan is known in City documents as the Parkrose-Argay Development Study (Ordinance No. 188470).

2. In April 2018, the City executed an Intergovernmental Agreement (IGA) with Metro accepting Metro's grant funds to draft the Plan (Ordinance No. 188881).

3. The Metro IGA requires the City to execute an IGA with the Parkrose School District to provide the district with resources for general coordination, a school enrollment capacity analysis related to development of the Rossi Farm site, student/community engagement and input for facility planning of school property.

NOW, THEREFORE, the Council directs:

- a. The Mayor is hereby authorized to execute an IGA with the Parkrose School District in a form similar to Exhibit 1.
- b. The BPS Director is hereby authorized to execute amendments to the IGA, including amendments that obligate additional City funds if the appropriations are approved by Council.
- c. The Mayor and Auditor are authorized to pay Parkrose School District from the BPS budget (Cost Object PN00770001) when demand is presented and approved by the appropriate City authority.

Section 2. The Council declares that an emergency exists because a delay in execution of the IGA would unnecessarily delay the City's ability to perform the activities authorized by the IGA. Therefore, this ordinance shall be in full force and effect from and after its passage by the Council.
