ORDINANCE No. 189314

*Authorize an Intergovernmental Agreement between the Portland Housing Bureau and Portland State University to provide Project Management for the leadership team at the Bureau Ordinance)

City of Portland ordains:

Section 1. The Council finds:

- 1. PSU and PHB desire to conclude an Intergovernmental Agreement (hereinafter "Agreement") to establish the terms and conditions of cooperative interaction between the parties to provide training to PHB leadership team on Project Management.
- 2. Collaboration with PSU benefits PHB with an in-depth and customized training from qualified higher education professionals with diverse experiences and perspectives, to aid PHB in planning, implementing and evaluating its increasingly complex and varied programs for providing affordable housing for the City of Portland.

NOW, THEREFORE, the Council directs:

- a. The Director of the Portland Housing Bureau is hereby authorized to execute an intergovernmental agreement with Portland State University in a form substantially similar to the agreement attached as Exhibit A.
- b. The Director of the Portland Housing Bureau is hereby authorized to sign amendments to modify the scope of the training up to 25% of the original contract amount.

Section 2. The Council declares that an emergency exists because this is an urgent training need for the bureau; therefore, this Ordinance shall be in full force and effect from and after its passage by the Council.
