- Indemnification: Subject to the limits and conditions of Oregon Law (ORS 30.260 through 30.300) and the Oregon Constitution, Article XI, Section 7, Presenter shall hold and save harmless Sponsor, its officers, agents and employees from claims, suits and actions arising out of the tortious acts of Presenter, its officers, agents or employees acting within the scope of their employment and duties in performance of this agreement. Sponsor shall hold and save harmless Presenter, its officers, agents, and employees from all claims, suits and actions arising out of the activities of Sponsor, its officers, agents, and employees acting under this agreement.
- **Assignment:** Neither party shall assign or transfer any interest in this agreement, nor assign any claims for money due or to become due during this contract, without prior written approval of the other party.
- **Termination:** The contract may be terminated by either of the parties with at least thirty (30) days prior written notice to the first day of the first seminar at no cost. Cancellation by the Sponsor 15-29 days prior to the first day will result in charges of 50% of the total program costs. Cancellation by the Sponsor with fourteen (14) or fewer days prior to the first day will result in charges of 100% of the total program costs.

Termination due to non-appropriation or budget limitation of funds:

If sufficient funds are not provided in future legislatively approved budgets of PSU (or from applicable Federal, state, or other sources) to permit PSU in the exercise of its reasonable administrative discretion to continue this Contact, or if PSU or the program for which this Contract was executed is abolished or budgetary limited, PSU may terminate this Contract without further liability by giving Sponsor not less than thirty (30) days notice. In determining budget limitation, PSU may use budget instructions from an applicable State of Oregon Agency, or the Governor's Office.

- **Force Majeure**: Neither Party shall be held responsible for delay or default caused by fire, riot, acts of God and war which are beyond its reasonable control. The affected party shall, however, make all reasonable efforts to remove or eliminate such a cause of delay or default and shall, upon cessation of the cause, diligently pursue performance of its obligation under the contract.
- Non-Discrimination: In their respective performances of this Agreement, no party shall unlawfully discriminate against any person on the basis of race, ancestry, national origin, color, sex, disability, age, religion, marital status or sexual orientation. Moreover, each party shall comport its performance with all applicable Federal and State anti-discrimination acts and associated regulations.
- **Tax Compliance Certification**: By signature on this Contract, the undersigned hereby certifies under penalty of perjury that the undersigned is authorized to act on behalf of Sponsor and that Sponsor is, to the best of the undersigned's knowledge, not in violation of any Oregon
