## ORDINANCE No.

\*Authorize payment to Carol Williamson and Associates, LTD for \$14,660 for work in retail space at the 3<sup>rd</sup> and Alder SmartPark (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

- 1. In August of 2018, Carol Williamson and Associates, a certified Women Business Enterprise, was asked to provide a proposal for a tenant improvement project at 318 SW Alder St, in the ground floor of the 3<sup>rd</sup> and Adler SmartPark garage.
- 2. The consultant provided a scope of work and cost estimate of \$14,659.80 for this work.
- 3. A Professional, Technical and Expert Services Purchase Order was issued and the consultant proceeded with the work.
- 4. Subsequent review of this purchase determined that it should have followed a Public Improvements and Construction Services contracting process under City Code 5.34, because the work involved demolition of features within the retail space.
- 5. The purpose of this Ordinance is to authorize payment to the consultant for work that has been provided to the City in good faith.
- 6. The Bureau's level of confidence in the cost estimate for this project is high as the work has been completed.

NOW, THEREFORE, the Council directs:

a. That the Portland Bureau of Transportation is hereby authorized to pay Carol Williamson and Associates, LTD in the amount of \$14,659.80.

Section 2. The Council declares that an emergency exists because the services have been received by the City; therefore, this Ordinance shall be in full force and effect from and after its passage by the Council.
