ORDINANCE No. 189317

Authorize a contract with the lowest responsible bidder for the SW Capitol Highway Pavement Rehabilitation Project SW Multnomah Blvd to SW Texas for an estimated \$2,024,646 (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

- On May 17th, 2016, Portland voters passed Measure 26-173, Portland's first local funding source dedicated to fixing our streets. Measure 26-173 will raise an estimated \$64 million over four years. This is the Portland Bureau of Transportation's (PBOT) Fixing Our Street Program.
- As part of the Fixing Our Street (FOS) program, PBOT will construct pavement maintenance work on SW Capitol Highway from SW Multnomah Blvd. to SW Texas St.
- 3. The pavement condition on SW Capitol Highway has deteriorated to a point that sections of it requires full-depth repair and other sections require a minimum of 2.5 grind and overlay.
- 4. Grinding and Paving 2.5 to 4.5 inches meets PBOT's Pavement Management Strategy of performing pavement maintenance earlier in the pavement lifecycle. Sections with damage sub-base will be reconstructed to PBOT's current pavement standard.
- 5. The Bureau of Transportation has funds budgeted in FY 2018 and proposed FY 2019 for construction, inspection and management of the project.
- 6. The Bureau's level of confidence in the cost estimate for this project is moderate as project scope is clearly understood and defined.

NOW, THEREFORE, the Council directs:

- a. Upon the Council's acceptance of the Chief Procurement Officer's report recommending the lowest responsible bidder, the Chief Procurement Office is authorized to negotiate and execute a contract, provided the contract has been approved as to form by the City Attorney's office.
- b. The Auditor to draw and deliver warrants chargeable to T00586.C35 when demand is presented and approved by the proper authority.
