Hello Mayor and Commissioners,

Thanks for your attentiveness yesterday during the district coalitions' presentation on equitable funding progress in the morning, and the Portland United Against Hate report in the afternoon. SE Uplift was happy to participate in both important discussions.

**I need to make a correction** to my statement yesterday in the morning session: SE Uplift staff DID in fact receive a pay increase for the 2018-2019 fiscal year. I mistakenly stated that they did NOT, and realized my error shortly after when I recalled the discussion of our Board of Directors when approving this year's budget. Our board insisted that staff get as high a cost of living adjustment as possible due to rising costs and the expense of Portland, and our budget reflected their decision, despite the cut in our contract with the City. I apologize for that error and wanted to make that correction.

Additionally, I am attaching the full testimony SE Uplift prepared in support of PUAH, since due to time constraints Commissioner Hardesty had to leave, and most of us who were final panelists either abbreviated or rushed our statements.

Thanks for your time, attention, and your support of the important community-government partnerships that PUAH and the district coalitions represent.

It was from relationships within PUAH that SE Uplift was able to collaborate so successfully with our community partners to install the Mulugeta Seraw street sign caps last November to honor his life and remember his murder.

SE Uplift has made the decision to allocate significant staff time to PUAH: we've re-written staff job descriptions to account for the time spent working on PUAH social media and newsletter, co-chairing committees, and more: SE Uplift is committed to and invested in the PUAH Coalition.
