Purpose of proposed legislation and background information:

- This Ordinance will give final approval to formation of a local improvement district ("LID") to survey, design and construct construct street, sidewalk, and stormwater improvements to NE 42nd Avenue, NE Columbia Blvd., and NE 46th Avenue, and traffic signal improvements at the NE 42nd Avenue & Columbia Blvd. intersection.
- Property owners have been extensively involved in the discussions related to this
 proposed LID. This LID was initiated by Council prerogative. There is no known
 opposition to this project, and this hearing provides a final opportunity for property
 owners to comment on the proposed LID.

Financial and budgetary impacts:

- Individual assessments for commercial and industrial properties range from \$26,796 to \$8,463,612.
- The level of confidence is Low.
- No change to staffing levels.
- 25% of the LID revenue (\$2,908,560.98) is to be added to the FY18-19 fiscal year budget and 75% of the LID revenue (\$8,725,682.95) is to be added to the FY18-19 fiscal year budget for total LID revenue of \$11,634,243.93.
- The project is not currently in the 5-year CIP.

Community impacts and community involvement:

- Property owner outreach has been ongoing since 2005 and has intensified since November 2017.
- A property owner meeting was held in September 2018.
- The LID was initiated by Council prerogative instead of by petition given a current ownership transition of the largest property in the LID and the need to have the first phase of construction of the LID complete by September 2020 if possible to support the region's transit service expansion goals.

PROPOSED AMENDMENTS TO NE 46TH AVENUE & SARATOGA COURT LOCAL IMPROVEMENT DISTRICT (LID)

Create a local improvement district to construct street, sidewalk, and stormwater improvements and construct a mast arm traffic signal at the NE 42nd Ave and Columbia Blvd intersection in the NE 46th Ave and Saratoga Ct Local Improvement District (Hearing; Ordinance; C-10065)

I. PROPOSED AMENDMENT REFLECTING CONTINUATION OF LID FORMATION HEARING.

Property owners received mail, publication and posting notice of the local improvement district (LID) formation hearing informing them of a December 12, 2018 Council hearing date. Due to a crowded December 12th Council agenda, the hearing was continued to January 9, 2019, which was announced during the December 12th Council proceedings by Mayor Wheeler as the presiding officer. The Local Improvement District Administrator sent mail notice of the hearing continuation on December 12, 2018 following the continuation. Therefore, it is requested that Council approve the following amendment:

Change the final sentence of Finding No. 3 of the Ordinance to:

The deadline to submit a written remonstrance was at 5:00 PM on December 5, 2018, which was extended to January 2, 2019, with no remonstrance received by either the original or extended remonstrance deadline



II. PROPOSED AMENDMENT TO AUTHORIZE LID FINANCING OF UTILITY INFRASTRUCTURE.

Pacific Power, as the local electrical utility serving the area of this LID, has indicated that current electrical transmission and distribution infrastructure is insufficient to serve the new Columbia Bus Base to be built on properties within the LID boundary. Pacific Power has indicated interest in coordinating with the Portland Bureau of Transportation (PBOT) to build additional electrical infrastructure within public rights-of-way within the LID boundary. It may be advantageous for property owner(s) to voluntarily finance portions of this infrastructure through the LID without this cost being spread to all assessable properties within the LID. Therefore, it is requested that Council approve the following amendment:

Change Directive 'i' of the Ordinance to:

The LID Administrator is authorized to negotiate Extra Work Agreements to finance, design and construct frontage <u>and/or electrical infrastructure</u> improvements for properties within the LID boundary beyond the project limits identified in Finding Nos. 11 through 14 of this Ordinance without a hearing per Section 17.08.080 of City Code provided that:

- The City Engineer has determined the additional work to be technically feasible; and
- ii. An Extra Work Agreement for properties or properties abutting the additional improvement been approved as to form by the City Attorney.

III. PROPOSED AMENDMENT TO REFLECT A NORTHERLY SHIFT OF THE NEW EAST-WEST STREET BUILT BY THIS LID AND A RESULTING STREET NAME CHANGE.

Right-of-way acquisition discussions with property owners has continued since Council approval of Resolution No. 37394, with concurrence among PBOT Civil Design Section, PBOT Right-of-Way Acquisition and PBOT Capital Delivery Division staff that shifting the street to the north would be more cost-effective and less disruptive in terms of impact. The street name to be assigned to this new east-west street does not match the current name of this LID. Therefore, it is requested that Council approve the following amendments:

a. Change the Ordinance title to:

Create a local improvement district to construct street, sidewalk, and stormwater improvements and construct a mast arm traffic signal at the NE 42nd Ave and Columbia Blvd intersection in the NE 46th Ave and Saratoga Ct Bryant St Local Improvement District (Hearing; Ordinance; C-10065)

b. Add new Directive 'm':

All unamended references to NE Saratoga Court in the record of Resolution No. 37394 and the record of this Ordinance also refer to NE Bryant Street

c. Replace the map in Exhibit C with the attached map.
