

## ORDINANCE No. 189377

Amend contract with OIR Group for the review of closed officer-involved shooting and in-custody death investigations to extend term and increase maximum compensation allowed under contract by \$60,000 (Ordinance; amend Contract No. 30005510)

The City of Portland Ordains:

Section 1. The Council finds:

1. The Independent Police Review is required by Portland City Code 3.21.070.L to contract with an outside expert to review closed officer-involved shooting and in-custody death investigations.
2. The City entered into Contract No. 30005510 in October 2016 with the OIR Group to conduct outside reviews. The contract expires on September 30, 2019.
3. The outside reviews have led to significant changes in Portland Police Bureau policies such as conducting criminal and administrative investigations for all officer-involved shootings and in-custody deaths, more timely investigations, and the creation of the Police Review Board.
4. Under the current contract the OIR Group has eliminated a backlog of eleven closed investigations awaiting review and has reviewed five additional closed investigations.
5. A contract amendment to extend the term of the contract through January 31, 2020, will allow the OIR Group to continue to conduct timely reviews of closed officer involved shooting and in-custody death investigations.
6. The maximum compensation to be paid to OIR Group under the current contract is \$140,000. Increasing the maximum compensation by \$60,000 due to the project extension will bring the maximum compensation allowed under the contract to \$200,000. A contract amendment that increases the original contract amount by more than 25% requires Council approval.
7. Funding for outside reviews, including the OIR Group contract, as amended, is included in Independent Police Review's requested FY 2019 - 2020 budget.

NOW, THEREFORE, the Council directs:

- a. The Director of Independent Police Review is authorized to amend the City's contract with the OIR Group in a form substantially in accordance with the agreement attached as Exhibit A, for the purpose described in Section 1.
- b. The Mayor and City Auditor are hereby authorized to pay for the contract from the Independent Police Review's 2019-2020 budget.
- c. The Director of Independent Police Review is authorized to extend the term of the

City's contract with the OIR Group through January 31, 2020.

- d. The Director of Independent Police Review is authorized to amend the City's contract with OIR Group to a maximum allowed compensation amount that shall not exceed \$200,000.
- e. Completed investigations closed by July 1, 2019, are eligible for review.


