*Create new Seasonal/Casual classifications of Community Service Aide III and IV and establish compensation rates for these classifications. (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. In accordance with the policies established by the City Council and based on a classification and compensation review, the Bureau of Human Resources is creating two new Seasonal/Casual classifications effective February 13, 2019.

Community Service Aide IV	February 13, 2019


- b. The following compensation rates are established:

Community Service Aide IV	
<u>Min</u>	<u>Max</u>
\$40.00	\$70.00
