

## ORDINANCE NO. 189388

\*Authorize a subrecipient contract with the Urban League of Portland for \$214,000 for services in support of fair housing and renter protection (Ordinance)

The City of Portland ordains:

Section 1. The Council finds that:

1. The Portland Housing Bureau (PHB) Strategic Plan prioritizes preventing families from losing their homes and promoting Fair Housing choice;
2. As part of implementing Strategic Plan goals, PHB used a competitive process to identify the Urban League of Portland and partners as a provider of culturally specific Fair Housing education and enforcement services;
3. Funding is included in the City's FY 2018-19 approved budget and will be available in PHB's FY 2018-19 adopted budget in the amount of \$214,000 through the General Fund (GF).


NOW THEREFORE, the Council directs that:

- a. The Bureau Director or designee is authorized to execute agreements with the Urban League of Portland for \$214,000, in a form substantially like the contract attached as Exhibit A.
- b. The Bureau Director is authorized to approve funding amendments up to 25% of the original budget amount of any contract covered under this ordinance.
- c. The Mayor and Auditor are hereby authorized to make payments on this contract from the PHB operating fund budget.

Section 2. The Council declares that an emergency exists because the program funds must be obligated within required timeframes; therefore, this ordinance shall be in full force and effect from and after its passage by Council.
