ORDINANCE No. 189412

Authorize grant agreement of \$10,000. for East Portland Neighbors Inc. to provide liability insurance coverage for meetings and events to engage East Portland residents in community building and civic engagement activities. (Ordinance)

The City of Portland Ordains:

Section 1. The Council finds:

- The City of Portland, Office of Community and Civic Life (Civic Life) funds the East Portland Community Office (EPCO), a city-administered District Coalition Office, to support community building and civic engagement activities by culturallyspecific, interest-based community groups and neighborhood associations in East Portland.
- Funding was adopted by the City Council as part of the FY 2018-19 Civic Life budget and is funded with a total of \$10,000 through City General Fund dollars. Providing insurance coverage for community events is an important service that removes barriers to participation in public events and supports East Portland's livability and civic life.
- 3. A grant of \$10,000 is going to East Portland Neighbors Inc., (EPN) to provide liability insurance coverage for community activities during the 2018/2019 fiscal year. The liability insurance will also provide coverage for the Directors and Officers for culturally-specific, interest-based community groups as well as the thirteen neighborhood associations in East Portland affiliated with EPCO and EPN for the 2018/2019 fiscal year.

NOW, THEREFORE, the Council directs:

- a) The Director of Civic Life is authorized to execute a grant agreement on behalf of the City in a form substantially similar to Exhibit A in the amount of \$10,000.
- b) Amendments to the grant agreement may be agreed to and executed by the Director of Civic Life, or the Director's designee, provided the amendments do not increase the City's fiscal risk.
- c) The Mayor is hereby authorized to pay for the grant agreement from funds allocated to Civic Life in the City's General Fund.
