Dear Jennifer:

New Cingular Wireless PCS, LLC ("AT&T") has finalized the terms of a franchise agreement with the City of Portland and is working with your staff to move this through the normal 4-6 month process of finalization

With the recent adoption of Resolution No. 37405 for the deployment of small cellular technology in the public right of way to enable 5G deployment, AT&T wishes to obtain a Temporary Revocable Permit under essentially the same terms as the pending franchise agreement so we can start the deployment of small cell technology in the public right of way.

Therefore, AT&T requests a new Temporary Revocable Permit to remain in force until the franchise agreement has been finally approved by the City Council.

AT&T understands the risk of deploying small cellular technology in the public right of way under a Temporary Revocable Permit if the Franchise Agreement is not approved. AT&T is willing to assume the risk under this TRP if the Franchise Agreement is not approved in order to proceed with its plan to deploy small cellular technology before the approval process has been completed. AT&T acknowledges that any expenditure, time, or other act is at risk under this permit. AT&T understands that upon revocation or expiration of the permit by the City, AT&T shall, within 60 days, remove the installed facilities and restore the street area as required by and to the satisfaction of the City Engineer, unless the franchise agreement replaces this permit.

In undertaking the proposed use of the City streets, AT&T acknowledges its covenant to indemnify and hold the City harmless as specified in the Temporary Revocable Permit. AT&T acknowledges that the Temporary Revocable Permit shall not become effective until such time as AT&T provides the City with proof of insurance providing coverage meeting the requirements set forth therein, or proof of adequate self insurance, which must be kept in full force and effect at all times during the term of the Temporary Revocable Permit.
