### STREET CLOSURE PERMITS FOR COMMUNITY EVENTS AND BLOCK PARTIES

Administrative Rule Adopted by Portland's Bureau of Transportation Pursuant to Rule-Making Authority PCC 3.12.010

ARB-TRN-10.06

#### I. Introduction

The Director of the Portland Bureau of Transportation is authorized to grant permits to close the street for block parties and community events within the public right-of-way. Permits for community events are defined as a local community event or regional community event alcohol prohibited, and a local or regional community event alcohol allowed. Fees are assessed per the current fee schedule approved by Council.

Block Party and Community event street closure permits allow closure of the public right-of-way to the extent that at least one sidewalk remains open at all times for pedestrian travel through the block. Community event permit holders shall not charge a fee to enter the event at an entry point within the public right of way.

A person will be denied a permit under PCC Section 17.24.017 C. & D. if more than 50 percent of the property owners abutting the street to be closed object to the closure or if another City Bureau objects to the closure based on concerns for neighborhood livability such as noise, disorderly conduct, litter, or public safety.

A person who is denied a permit under PCC Section 17.24.017 C. & D. may appeal the matter to City Council. The applicant shall file with the City Auditor within five days after denial a written notice of appeal. The notice shall identify the decision that is being appealed, and include the appellant's name, address, phone number, signature, and a clear statement of the specific reason(s) for the appeal. Upon receipt of such appeal, the Auditor shall then place the matter upon the Calendar of the City Council. At the hearing, the Council may affirm or modify the decision of the Director of the Bureau of Transportation as the Council may deem necessary.

#### II. Complaints and Opposition to Permit Issuance

Permits for street closures as defined in section III Definitions below are intended to build a sense of community. If the local neighborhood association objects to the issuance of a particular permit, they may contact their District Coalition Office or The Office of Neighborhoods to register a complaint. #### III. Definitions

Block Parties are events that typically close no more than one block of a local service residential street for small-scale parties such as neighborhood potlucks and barbecues. Block parties are usually held on weekends or holidays. This type of permit is initiated by local residents who live on the street being closed. Application is made directly with City of Portland Bureau of Transportation. The block party phone line is 503.823.4003.

Community Event Street Closures – Alcohol Prohibited prohibits use of alcohol in the public right of way during the event. There are two classifications of events: 1. Minor Neighborhood (Local) Events are larger than block parties and include more than just the residents living in the immediate vicinity of the closed street area. These events may close more than one block for neighborhood-wide events. 2.
