Portland Planning and Sustainability Commission Update

Advancing Equity in Waste Collection

April 26, 2019

Last October, City Council renewed the residential franchise agreement and also accepted a new Waste Equity Workplan that lays out BPS' efforts to advance equity across all sectors of Portland's waste collection system over the next five years. Council directed BPS staff to work with stakeholders and partners to begin implementation and report back on progress in one year.

The Waste Equity Workplan (available online at www.portlandoregon.gov/bps/article/709965), identifies a number of efforts in line with our guiding principles to:

- Increase participation of women and minority workers, and
- Reduce barriers to economic opportunities for minority-owned and woman-owned companies.

Waste Equity Plan Highlights

- The first workplan item we moved forward involves our own **City waste collection contracts**. As the customer, the City has more flexibility and control over the procurement approach. There are also changes planned for City contracts and a chance to do things differently as we move forward.
- In December, BPS secured authorization from City Council to use a different approach for procuring public waste collection services. BPS now has direction to develop a new **Waste Collection Access and Opportunity program**. The program will create a pool of vetted and pre-qualified minority-owned and woman-owned vendors and direct public waste collection contracts through that new program. The program would include operational and technical assistance to support participant capacity-building. The first procurement using this new approach—collection from 200 public trash cans in East Portland—hits the streets at the beginning of May.
