

ORDINANCE No. 189465

Authorize a competitive solicitation and contract with the lowest responsible bidder and provide payment for construction of Hillsdale South Sewer Rehabilitation, Project No.E10681 for an estimated cost of \$2,065,000 (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. The Bureau of Environmental Services (BES) needs to rehabilitate approximately 7,200 feet of sewer main line in the southwest neighborhoods of northern Multnomah and southern Hillsdale.
2. The Bureau Environmental Services has prepared plans and specifications for rehabilitating or replacing the deteriorated sewer pipe, including sewer manholes and service laterals.
3. The established cost is \$2,065,000. Funds are available in the Sewer System Operating Fund, FY 19-20 Budget, Bureau of Environmental Services, Cost Center, WBS Element E10681

NOW, THEREFORE, the Council directs:

- a. That the Commissioner-in-Charge is authorized to execute a contract with the lowest responsive bidder for the purposes described in Section 1, in the amount of \$2,065,000.
- b. The Mayor and City Auditor are hereby authorized to pay for the contract from the Sewer System Operating Fund Budget when demand is presented and approved by the proper authority.


