

ORDINANCE No. 189466

Authorize an Intergovernmental Agreement with the Oregon Department of Fish and Wildlife to conduct stream habitat surveys in Portland's waterways not to exceed \$498,686 (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. In July 1998, the Portland City Council adopted Resolution No. 35715 to guide the City's response to the Endangered Species Act (ESA). In May 2000, the Council adopted a Framework for an Endangered Species Recovery Plan through Resolution No. 35894. That Framework described the analytical approach for developing the City's response to the Endangered Species Act.
2. In June 1999, the Council approved an agreement with Oregon Department of Fish and Wildlife to conduct comprehensive stream habitat surveys (Ordinance No. 173440). The habitat data collected through this effort provided the City with essential information on baseline stream conditions that the City has used extensively to inform watershed management and endangered fish recovery efforts.
3. The Portland City Council adopted the Framework for Integrated Management of Watershed Health in March 2006 as part of the 2005 Portland Watershed Management Plan, Resolution No. 36384. The framework defines healthy urban watersheds and watershed health goals, including goals for biological communities and the essential habitat that supports these sensitive species, particularly ESA-listed salmon and steelhead.
4. Since 1999 the City has implemented 44 restoration projects throughout Portland's watersheds to better manage stormwater and protect infrastructure while improve conditions for fish and other aquatic organisms. The benefit of these efforts is evident: we have seen an increase in the number of salmon returning and spawning in Portland's streams. Twenty years of projects and urban development have changed Portland's streams
5. Since 2014, BES has been developing an asset management based Stormwater System Plan that incorporates grey, green, and natural infrastructure as part of a comprehensive stormwater management system. This new ODFW stream habitat data will provide the City with a detailed and up-to-date dataset that the City will use to assess how Portland's stream habitat has changed over the past two decades, its current condition, and inform where the bureau should invest future resources and projects. Additionally, the City will use the stream habitat data to support ESA-listed fish recovery, the City's Salmon-Safe certification (Resolution No. 37244) including a future update of the Ecosystem Diagnosis and Treatment (EDT) modeling of fish response to support fish recovery (Ordinance No. 188352), and for natural area management.
6. The established cost for the Intergovernmental Agreement is not to exceed \$498,686.00. Funds for fiscal years 2018-2019, 2019-2020, and 2020-2021 expenditures are available in the Watershed Services Group's Stormwater System Plan Programs' Budget, Bureau of Environmental Services, WBS Element ESWS000014.

NOW, THEREFORE, the Council directs:

- a. The Commissioner-in-Charge or their delegee is hereby authorized to enter into an IGA with Oregon Department of Fish and Wildlife in a form similar to the agreement attached as Exhibit A.
- b. The Mayor and Auditor are hereby authorized to pay for the contract from the Sewer System Operating Fund Budget when demand is presented and approved by the proper authority.
