

## ORDINANCE No. 189480

\*Authorize the Director of Bureau of Planning and Sustainability to execute a \$10,000 grant agreement with PolicyLink for a site visit for work with the Portland Anti-Displacement Network team (Ordinance)

The City of Portland ordains:

Section 1. The Council finds

1. In 2015, the City Council adopted a new 2035 Comprehensive Plan with social equity and anti-displacement policies championed by Anti-Displacement PDX, a coalition of community based organizations working on housing and community development issues with Portland's low-income residents and communities of color.
2. In 2015, the Portland City Council awarded Anti-Displacement PDX the Spirit of Portland Award in recognition of their advocacy work on the 2035 Comprehensive Plan.
3. In 2018 PolicyLink, a 501(c)(3) non-profit organization based in Oakland, California launched the All-In Cities Anti-Displacement Policy Network in response to the growing crisis in U.S. cities of low-income households and communities of color being displaced out their neighborhoods and cities.
4. PolicyLink invited the City of Portland and members of the Anti-Displacement PDX coalition to become a member city of the All-In Cities Anti-Displacement Policy Network in 2018. The Portland team is composed of local leaders, including staff from the offices of Mayor Wheeler and Commissioner Eudaly, city staff from the Bureau of Planning and Sustainability, Portland Housing Bureau, and Prosper Portland, and community leaders from the Community Alliance of Tenants and Portland State University.
5. PolicyLink seeks to better understand Portland's existing local racial disparities, government's role in maintaining and exacerbating those disparities, and capture the lessons learned and examples of new approaches being taken to prevent displacement.
6. The Bureau of Planning and Sustainability seeks to fund PolicyLink to come to Portland for a two-day site visit in June of 2019 as part of their work to support the All-In Cities Anti-Displacement Policy Network.

NOW, THEREFORE, the Council directs:

- a. The Director of Bureau of Planning and Sustainability is authorized to execute a \$10,000 grant agreement with PolicyLink substantially in accordance with the agreement attached as Exhibit A: Grant Agreement.

- b. "The City Council waives the competitive application process required in FIN 2.04 – Budget." in conformance with the scope of work and budget detailed in Exhibit A.

Section 2. The Council declares that an emergency exists because a delay would unnecessarily delay the City's ability to perform the activities authorized by the grant. The activities of this grant further the City's efforts to preserve existing affordable housing and increase the supply of new affordable housing. Therefore, this ordinance shall be in full force and effect from and after its passage by the Council.
